Quotation and Tendering

The minimum required numbers of tenders or quotations from appropriate contractors for a given estimated value of contract are:

- Above £3,000 & up to £50,000 3 written quotations:
- Above £50,000 3 formal quotations to be submitted in writing by a specified date and time and based on a written specification and evaluation criteria
- In line with the Government new Public Procurement Policies and Procedures and under the new Find a Tender portal (FTP)

Procedures

All purchases with a value greater than £50,000 must be put out to formal tender. The following procedures must be followed in such circumstances:

- A specification will be prepared, authorised by the chair of the relevant committee and CEO and sent to at least three suppliers. It is anticipated that for any major building works of a value greater than £10,000 the services of an architects would be engaged to deal with the handling of specifications and suitability to tender.
- 2. Where appropriate, the suppliers invited to tender should be drawn from an approved list **or** from those agreed with the architect. Otherwise, invitations to submit tenders will be advertised in local newspapers and trade journals if appropriate. The invitations to tender will include:
 - (a) an introduction/background to the project;
 - (b) the scope and objectives of the project;
 - (c) any technical requirements;
 - (d) implementation details for the project;
 - (e) the terms and conditions of the tender; and
 - (f) the form and date of response to the academy, or in the case of building works, to the architect or quantity surveyor.
- 3. All replies, if to the academy, should be addressed to the Trust Finance & Procurement Officer in a plain sealed envelope marked 'Tender' to reach him/her by a specified date. All replies must be kept sealed until that date and passed to the chair of the relevant committee.
- 4. All tenders will be opened at the same time and details of the contractor, quotation and any other details recorded at the time of opening,
- 5. No contractor will be allowed to amend the tender after the time fixed for receipt.
- 6. The Trust Finance & Procurement Officer will open a separate correspondence file for each tender which will contain copies of all correspondence or other relevant information.

- 7. For purchases up to £50,000, provided the expenditure is included in the budget, the decision as to which tender to accept will be taken by the CEO, in consultation with the Chief Finance Officer, Trust Finance & Procurement Officer and the Chair of the Finance, Resources and Staffing Committee.
- 8. For purchases exceeding £50,000, provided the expenditure has been budgeted for, a decision will be recommended by the Finance, Resources and Staffing Committee. The decision will need to be ratified by the full Board of Directors.
- 9. Where expenditure is not included in the budget or anticipated expenditure exceeds the budget allocation, the decision as to which tender to accept will be taken by the Finance, Resources and Staffing Committee, in line with their terms of reference and then ratified by the full Board of Directors; and
- 10. The reasons for accepting a particular tender must be documented, especially if it is decided to accept other than the lowest tender. All decisions must be reported to the full Board of Directors and follow the ADMAT Best Value statement.

Acceptance of Tender

The following points will be considered when deciding which tender to accept:

- 1. The overall price and the individual items or services which make up that price.
- 2. Whether there are any 'hidden costs'; that is additional costs which the academy will have to incur to obtain a satisfactory product.
- 3. Whether there is scope for negotiation, while being fair to all tenderers.
- 4. The qualifications and experience of the supplier, including membership of professional associations.
- 5. Compliance with the technical requirements laid down by the academy.
- 6. Whether it is possible to obtain certificates of quantity.
- 7. The supplier's own quality control procedure; pre sales demonstrations, after sales service and, for building works, a six month defects period and insurance guarantees.
- 8. The financial status of the supplier.
- 9. References from other establishments.
- 10. Understanding & compliance with Health & safety, CDM regulations and Child Protection issues related to working on a school site
- 11. Consider sustainability when reviewing products and services for schools and Trust quotes and Tenders

In the case of building works, where the tendering process is being carried out by the architect or quantity surveyor, they will be responsible for checking the documents of all tenders before making a recommendation to the academy.

Once a tender is accepted an order should be issued immediately to the supplier in the normal way.

The successful contractor should be informed that the school is a NON SMOKING site

The MAT Funding Agreements (Master/Supplementary) will be considered for this policy
